Attached you will find our 2015 Estimate of Taxable Values. The numbers shown in this estimate will be similar to the numbers which will be on the DR-420 (Certification of Taxable Value) on July 1, 2015. The only changes between the enclosed estimate and the DR-420 certification will be to correct any errors discovered over the next few weeks, to update tangible personal property values based upon returns not yet received/processed, and to extend any exemptions received and approved between today and July 1, 2015. All new 2015 exemption and Save Our Homes portability applications filed to date are reflected in the enclosed numbers.

Residential sales from the first few months of 2015 indicate property values continue to appreciate in most parts of Broward County. For planning purposes, you should expect to see the tax roll increase slightly for next year. We do not anticipate the significant increases we experienced for 2015 to continue into 2016.

Please remember the 2015 assessments reflect the values as of January 1, 2015 as set by qualified sales during the January 2, 2014 through January 1, 2015 assessment period.
