special benefit as set forth in the Initial Assessment Resolution.

- (B) The method for computing Fire Protection Assessments described and referenced in the Initial Assessment Resolution is hereby approved. The Parcel Apportionment methodology described in Appendix G of the Initial Assessment Resolution and adopted in Section 7 of the Initial Assessment Resolution is hereby approved.
- (C) For Fiscal Year 2011-2012, beginning October 1, 2011 through September 30, 2012, the total estimated Fire Protection Cost is determined to be \$1,888,034.00. The Fire Protection Assessments to be assessed and apportioned among benefited parcels pursuant to the Cost Apportionment and Parcel Apportionment to generate the estimated Fire Protection Assessed Cost for FY 2011-2012, are hereby established as follows:

Fire Protection Assessments for fire protection services in the amounts set forth in the Assessment Roll, as herein approved, are hereby levied and imposed on all parcels of Assessed Property described in such Assessment Roll for Fiscal Year 2011-2012, beginning October 1, 2011 through September 30, 2012.
