COLUMN I -- "LAST YEAR'S ACTUAL TAX RATE'

* COLUMN 2 -- "THIS YEAR'S PROPOSED TAX RATE"

This column shows what your tax rate will be this year under the BUDGET ACTUALLY PROPOSED by each taxing authority.

* COLUMN 3 -- "YOUR PROPERTY TAXES LAST YEAR"

- This column shows the taxes that applied last year to your property. These amounts were based on budgets adopted last year and your property's previous taxable value.
