COLUMN I -- "LAST YEAR'S ACTUAL TAX RATE"

This column shows the tax rate adopted by each taxing authority and applied to your property last year.

This column shows what your taxes will be this year IF EACH TAXING AUTHOR-ITY DOES NOT CHANGE ITS PROPERTY TAX LEVY. These amounts are based on last year's budgets and your current assessment. MARKET VALUE:

This is our opinion of the real value of your property on the open market on January I of this year (based upon qualified sales of similar properties last year).

ASSESSED/SOH VALUE:

ASSESSMENT REDUCTIONS:

Non-ad valorem assessments are set based on characteristics including (but not limited to) type of building, lot size, building size, or number of residential units. Non-ad valorem assessments are placed on this notice at the request of the local governing boards. The Broward County Revenue Collection Division will be including these on your November tax bill. For details on particular non-ad valorem assessments, contact the taxing authorities listed above. The phone number for each is listed in the column with the date, time and location of the public hearing.
