#### **EXPLANATION OF PROPERTY APPRAISER INFORMATION AND ADVALOREM TAXES:**

#### COLUMN I -- "LAST YEAR'S ACTUAL TAX RATE"

This column shows the tax rate adopted by each taxing authority and applied to your property last year.

## \* COLUMN 2 -- "THIS YEAR'S PROPOSED TAX RATE" This column shows what your tax rate will be this ye

#### \* COLUMN 6 -- "YOUR TAXES IF NO BUDGET CHANGE IS ADOPTED"

#### MARKET VALUE:

Non-ad valorem assessments are set based on characteristics including (but not limited to) type of building, lot size, building size, or number of residential units. Non-ad valorem assessments are placed on this notice at the request of the local governing boards. The Broward County Revenue Collection Division will be including these on your November tax bill.
