MARKET VALUE:

This is our opinion of the real value of your property on the open market on January I of this year (based upon qualified sales of similar properties last year).

Non-ad valorem assessments are set based on characteristics including (but not limited to) type of building, lot size, building size, or number of residential units. Non-ad valorem assessments are placed on this notice at the request of the local governing boards. The Broward County Revenue Collection Division will be including these on your November tax bill. The phone number for each is listed in the column with the date, time and location of the public hearing.
