#### COLUMN I -- "LAST YEAR'S ACTUAL TAX RATE"

#### MARKET VALUE:

#### ASSESSMENT REDUCTIONS:

Properties can receive an assessment reduction for a number of reasons, including the Save Our Homes (SOH) benefit, portability, the 10% cap property assessment limitation and the agricultural classification. Not all assessment reductions apply to all taxing authorities.

#### **EXEMPTIONS:**

Specific dollar or percentage reductions in value are based on certain qualifications of the property owner. Exemption examples include homestead/additional homestead, widow/widower, disabled veteran, disability and seniors. #### TAXABLE VALUE:

This is the value used to calculate the taxes on your property. The taxable value is the assessed value minus the value of your exemptions.

# **NON-AD VALOREM ASSESSMENTS:**

Ad valorem taxes are set based on the value of property. Non-ad valorem assessments are set based on characteristics including (but not limited to) type of building, lot size, building size, or number of residential units. Non-ad valorem assessments are placed on this notice at the request of the local governing boards. The Broward County Revenue Collection Division will be including these on your November tax bill. For details on particular non-ad valorem assessments, contact the taxing authorities listed above. The phone number for each is listed in the column with the date, time and location of the public hearing.
